SOUTH AYRSHIRE HEALTH AND SOCIAL CARE PARTNERSHIP LOCALITY PROFILES

1. <u>PURPOSE OF REPORT</u>

1.1 The purpose of this report is to provide members with a summary of the SAHSCP revised Locality Profiles.

2. **RECOMMENDATION**

3. BACKGROUND INFORMATION

3.1 This report seeks to set out the key issues for the SAHSCP as highlighted in the revised Locality Profiles (see Background Papers).

4. <u>REPORT</u>

- 4.1 Revised Locality Profiles have prepared by the Public Health Scotland LIST team in partnership with the SAHSCP Planning and Performance Team. This report highlights the overall key issues for the Partnership in terms of Demographics, General Health, Lifestyle and Risk Factors, Hospital and Community Care. It also highlights issues and differences which are observed within particular localities. The Locality Profiles are used within the Locality Planning Partnerships to help determine their local priorities.
- 4.2 Key points from the Locality Profiles are noted below and presented in the Summary Table in Appendix 1.

4.2.1 Demographics

- The Ayr South Locality has the highest proportion of its population aged over 65 at 29.1% compared with 26.1% across South Ayrshire and 19.6% across Scotland. Ayr North has the lowest proportion of its population aged 65 and over at 19.3%.
- The Ayr North Locality has the highest percentage of its population in the most deprived SIMD quintle at 58.7% compared with 16.7% across South Ayrshire and 20% across Scotland.

4.2.2 Housing

• Ayr North has the highest proportion of households with single occupant tax discount at 41.2% compared with 36.7% across South Ayrshire and 38.5% across Scotland.



• Ayr North and Girvan and South Carrick have a significantly higher proportion of Households in Council Tax Bands A-C at 84.1% and 73.2% respectively compared to South Ayrshire at 51.4% and Scotland at 58.9%.

4.2.3 General Heath

- Male Life Expectancy is highest in the Prestwick Locality at 79 and lowest in the Ayr North Locality at 72.2. Male life expectancy across South Ayrshire is 77 which is slightly higher than the national average of 76.5%.
- Female Life Expectancy is highest in the Troon and Ayr South Localities with both seeing an average of 82.7 years. Female life expectancy is lowest in Ayr North at 77.2 which is lower than the South Ayrshire and Scottish averages which are each aligned at 80.7.
- The Girvan Locality has the highest proportion of its population living with a long-term condition at 28.7% which is higher than the South Ayrshire average of 28% and the Scottish average of 21.7%.
- Cancer registrations are highest in the Ayr North Locality at 719.3 per 100,000 and lowest in the Troon Locality at 559.7. South Ayrshire has a lower than national average of cancer registrations than Scotland at 614.5 comparted to 630.3 nationally.
- Ayr North has the highest proportion of the population in receipt of prescriptions for Anxiety, depression and psychosis at 28.4% with the Troon Locality having the lowest at 19.9% which is both lower than the overall South Ayrshire and Scottish averages.
- 4.2.4 Lifestyle and risk factors
 - Alcohol related hospital admissions are significantly highest in the Ayr North Locality at almost double that of the rate across the whole of South Ayrshire and Scotland. Admissions are lowest in the Prestwick locality.
 - Similarly Drug related hospital admissions are significantly highest in the Ayr North locality and also around double that of the rate across the whole of South Ayrshire. Drug related admissions are also lowest in the Prestwick locality.
 - Bowel Screening uptake is highest in the Ayr South Locality and lowest in Ayr North.

4.2.5 Hospital and Community Care

- The rate of emergency admissions to hospital per 100,000 population is highest in the Ayr North Locality and lowest in the Ayr South Locality.
- The Girvan locality has the highest rate of unscheduled bed days at almost double the national rate. The Maybole locality has the lowest rate.
- A & E attendances are highest in the Ayr North locality and lowest in the Girvan locality.
