# ADULT CARERS STRATEGY – UPDATE

### 1. <u>PURPOSE OF REPORT</u>

1.1 Following on from the Adult Carers paper discussed at SPAG on 18<sup>th</sup> March 2025, the purpose of this report is to provide members with an update on progress around the consultation as we develop a refreshed Adult Carers Strategy.

### 2. RECOMMENDATION

It is recommended that the Strategic Planning Advisory Group:

- I. Note the progress being made and the early consultation feedback received in refreshing the Adult Carers Strategy; and
- II. Note that progress reports on the revised strategy development will be brought to next SPAG meeting until the final strategy is approved at IJB.

#### 3. BACKGROUND INFORMATION

- 3.1 The refresh of the Adult Carers Strategy commenced in January 2025. We considered from the outset both learning from the previous strategy alongside the updated Scottish Government National Strategy 2022 and more recent updated statutory guidance.
- 3.2 Our timetable for this work is set out below and we have an engagement plan in place that ensures our consultation and engagement with carers to gather their lived experience feedback covers all our localities.
- 3.3 Our timeline for strategy development is as follows:

## 4. <u>REPORT</u>


4.1 We are continuing to develop an Integrated Impact Assessment; explore the current policy landscape and carry out local engagement sessions across all localities. The chart below sets out who we have consulted with so far alongside the scheduled sessions that are included in our communication and engagement plan.

- 4.2 All consultation is being carried out and supported by the Adult Carers Policy Officer alongside support from Planning and Performance to ensure the timeline and development of the strategy remains on track.
- 4.3 The Adult Carers Strategic Planning Group continues to meet monthly and is being utilised as a steering group to provide governance and monitor progress. This group is made up of senior operational staff from across adult services and also includes wider sector stakeholders.



4.4 It is worth noting that as we continue to consult and develop our new Carers Strategy, we are also continually monitoring our current approach to supporting carers. As set out below, this year has seen the highest number on record of Adult Carers Support Plans completed by our statutory teams, and we are keen to highlight and continue this progress moving forward.



4.5 We are also planning for Carers Week from 9<sup>th</sup> to 15<sup>th</sup> June with the theme this year 'Caring about Equality.' The Carers Centre in Ayr are taking the lead this year for delivering carers week and this will provide a range of activities, information and advice sessions all aimed at identifying and supporting carers across South Ayrshire. Leisure services have also agreed to provide free access to all leisure activities for adult carers throughout carers week.
