Introduction

This survey for children and young people was carried out as part of our joint inspection of services for children and young people subject to compulsory supervision orders living at home with their parents in South Ayrshire.

The survey was aimed at children and young people subject to compulsory supervision orders living at home with their parents. The survey did not ask children and young people to identify themselves and was therefore anonymous. The purpose of the survey was to gather children and young people's views on their experiences of support to help:

- to be listened to, treated with respect and included
- to stay safe at home, in the community, at school and online
- to improve wellbeing – physical health, mental health, engagement at school, physical activity and relationships
- to make and keep loving and supporting relationships.

Method

We developed the survey using a range of approaches including:

- involving our young inspection volunteers who have lived experience of children's services
- consulting children and young people with care experience
- reviewing feedback from children and young people who have completed surveys
- researching other survey tools and approaches.

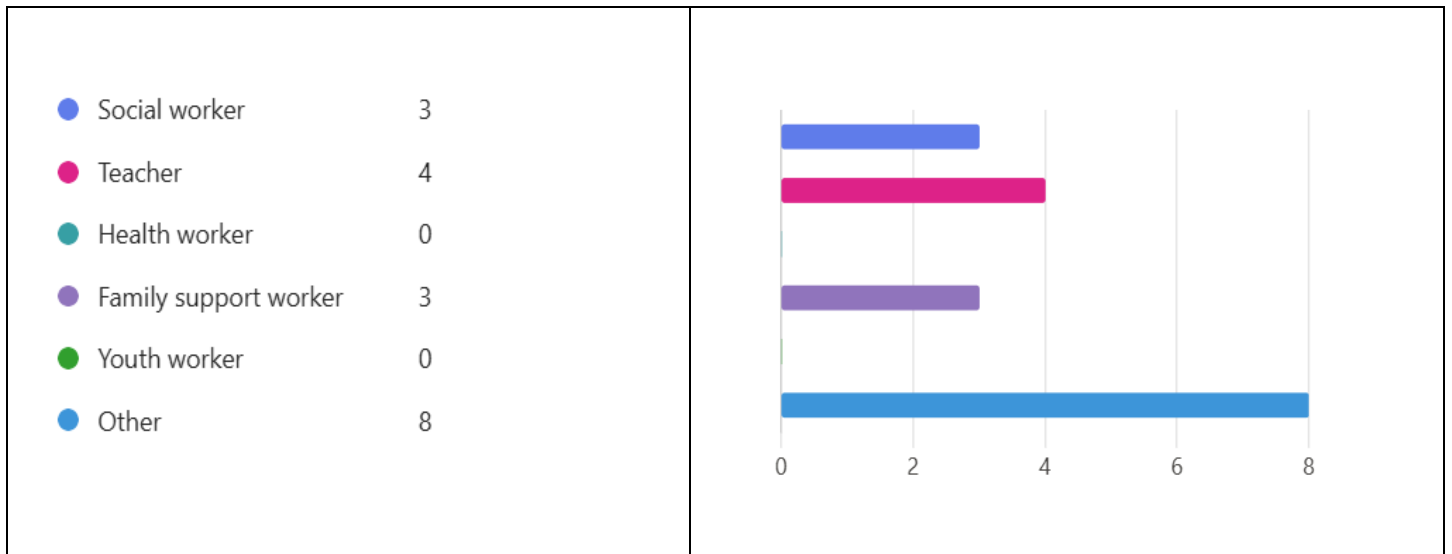
Local partners were tasked with distributing and supporting children and young people, aged 8 and over, to complete the surveys. We advised local partners to carefully consider the appropriateness of the survey based on the needs of each individual child or young person, given surveys are not appropriate for all. We recommended that all children and young people be offered support to complete the surveys. We translated the survey into other languages if partners requested this, to ensure accessibility.

The survey results form one type of inspection evidence. During the joint inspection, inspectors use a range of other methods to gather the views and understand the experiences of children and young people.

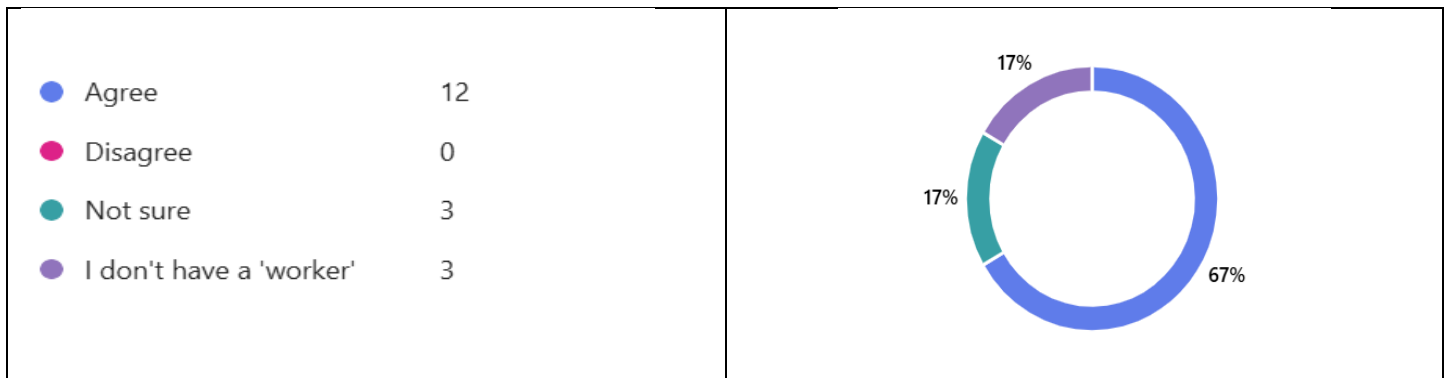
Please note that:

- Where comparisons have been made, the significance of any differences has not been measured.

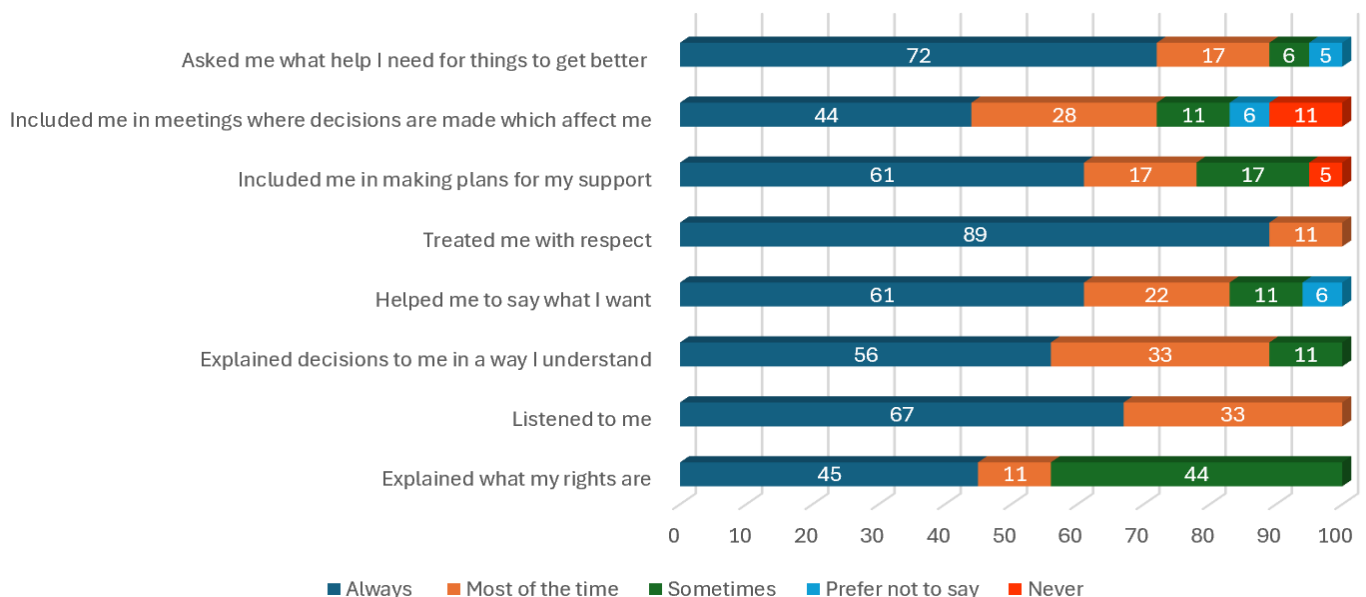
Question 1 – Who gives you most of the help you need



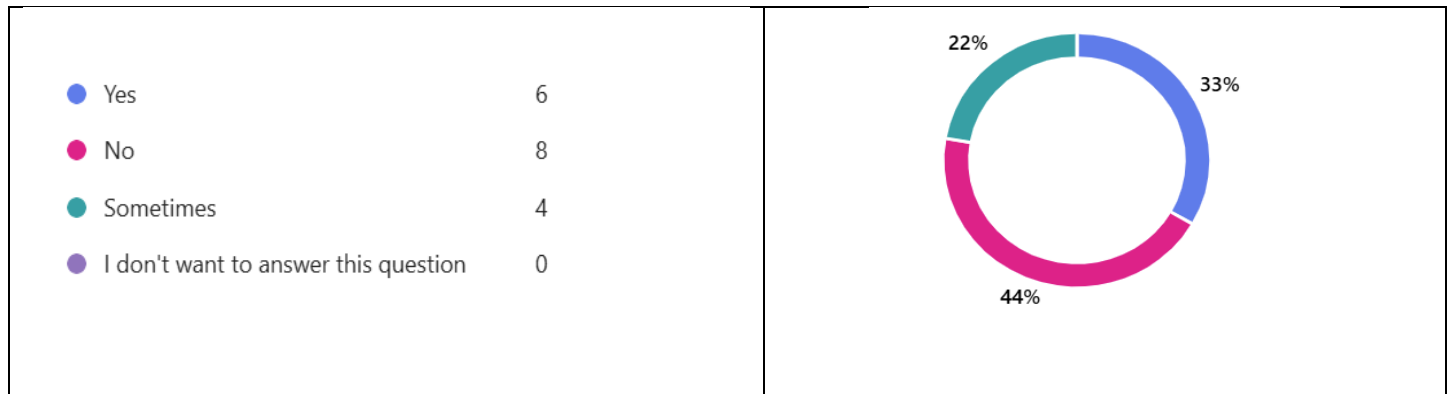
Question 2 – I know why my worker is working with me and my family



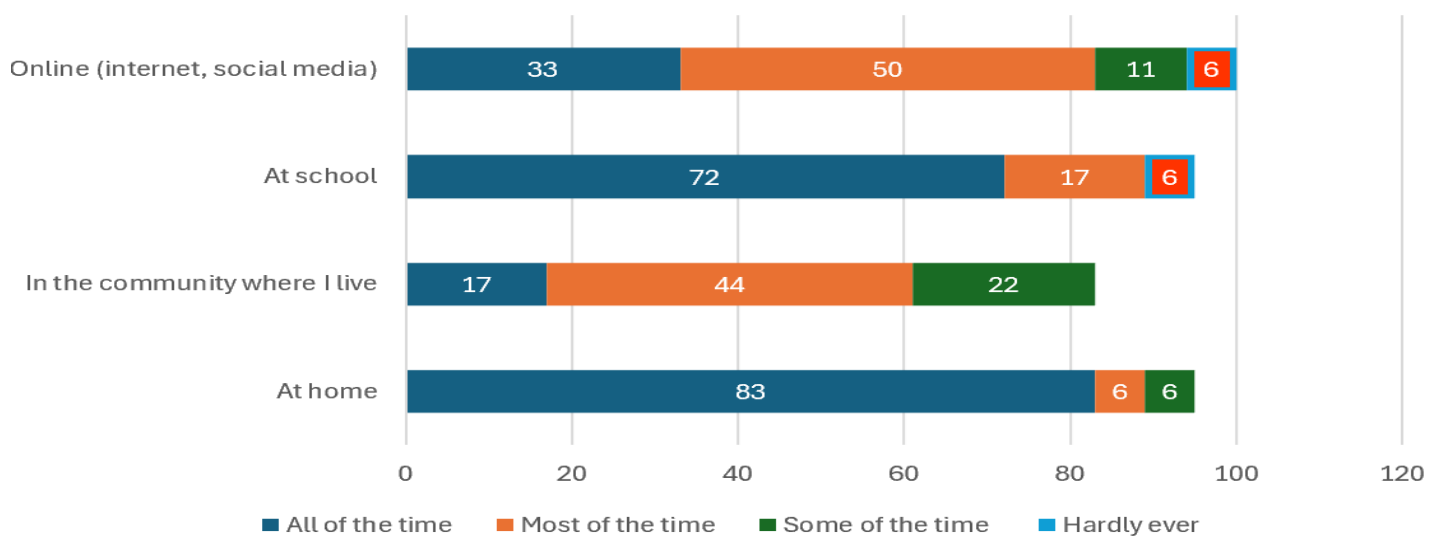
Question 3 - In the last couple of years people working with me have:



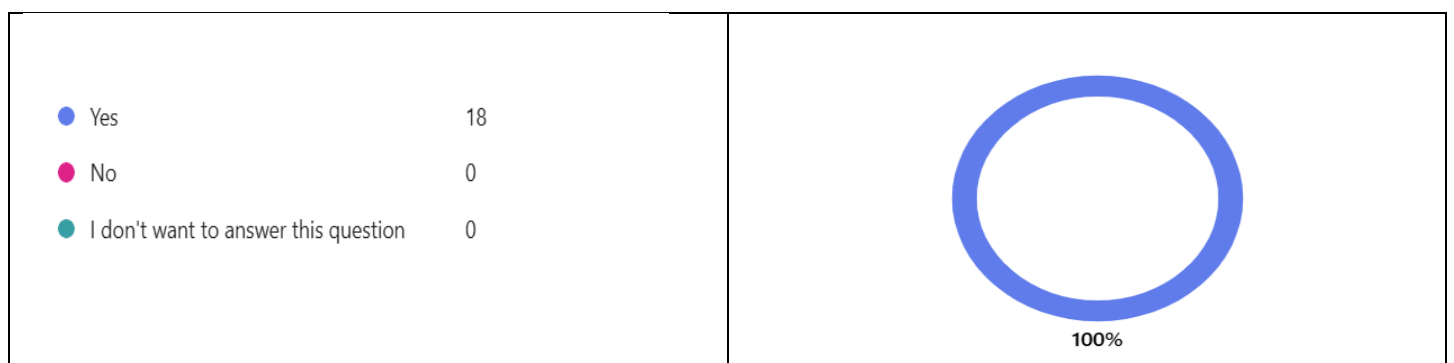
Question 4 - In the last couple of years have you needed help to feel safer?



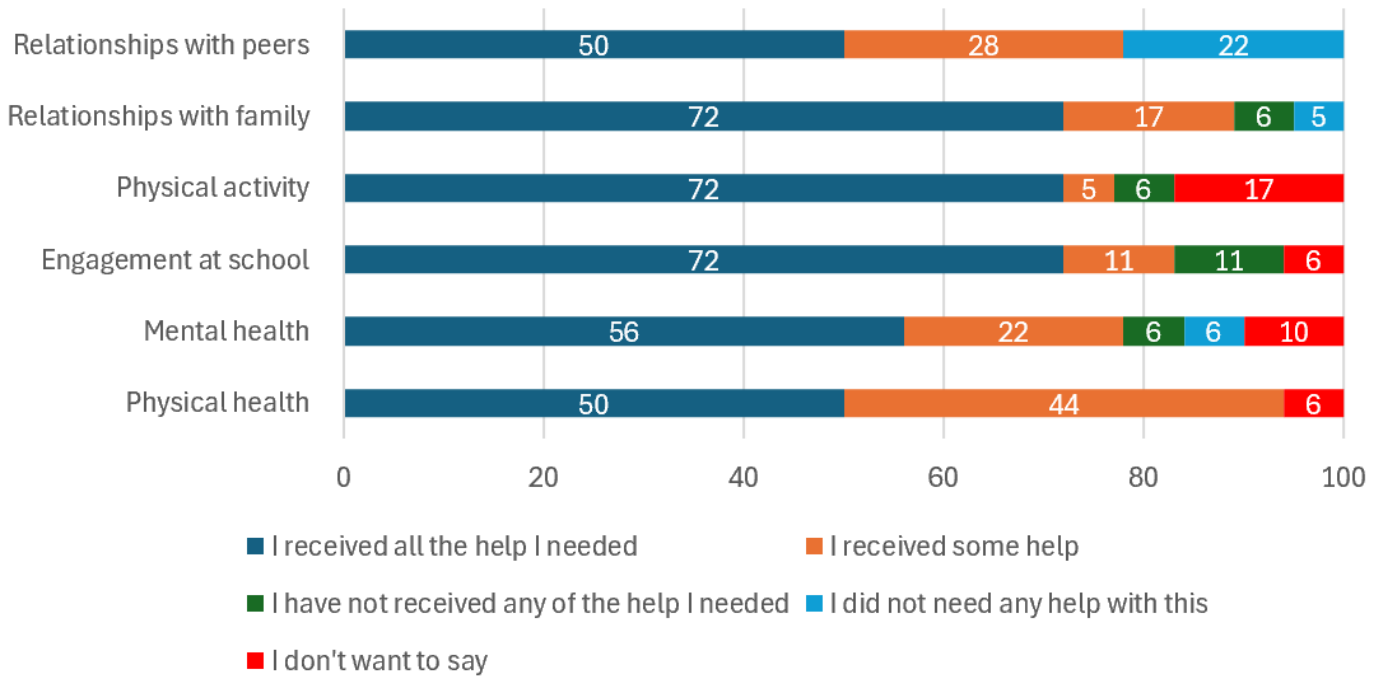
Question 5 - Where do you feel safe



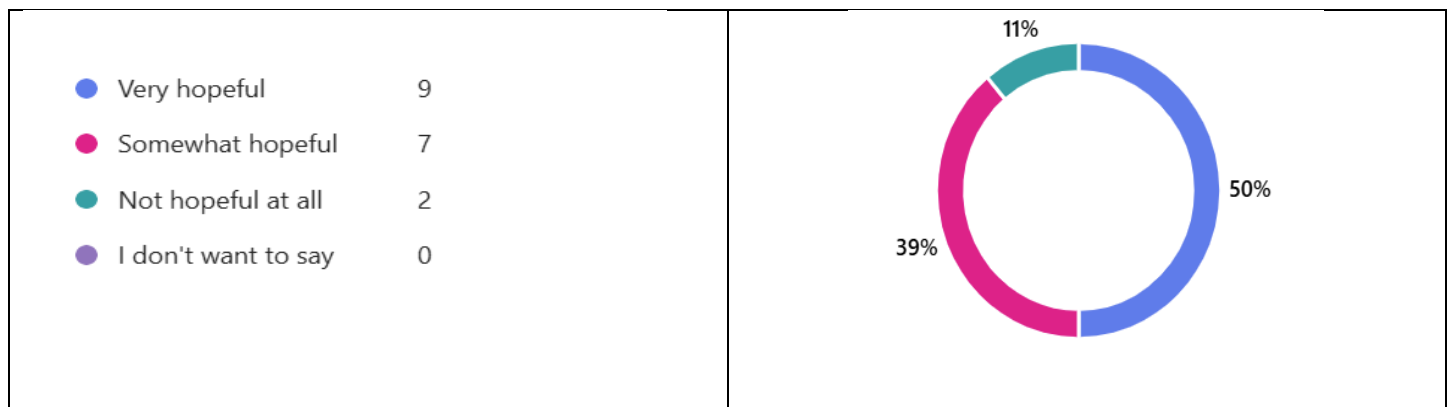
Question 6 - I have an adult I can talk to if I don't feel safe



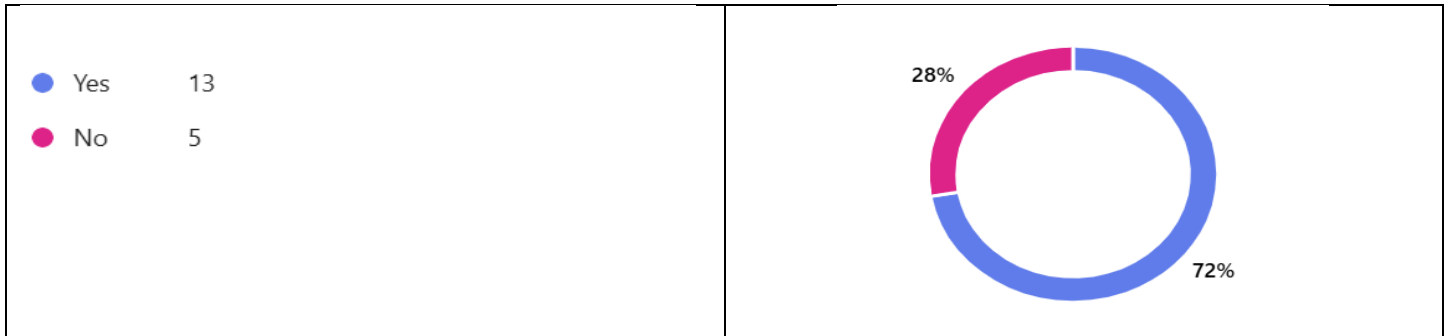
Question 7 - Have you received the help you needed in the last couple of years to help improve your



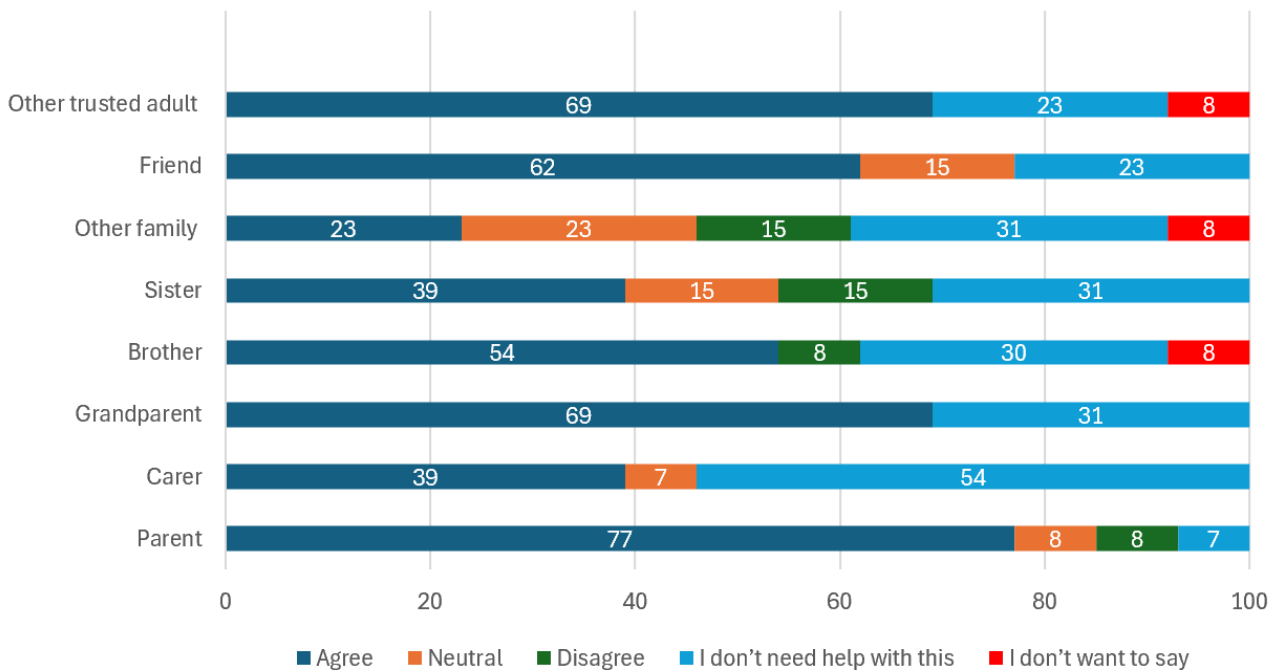
Question 8 – Due to the support you have received or are receiving how hopeful are you for the future.



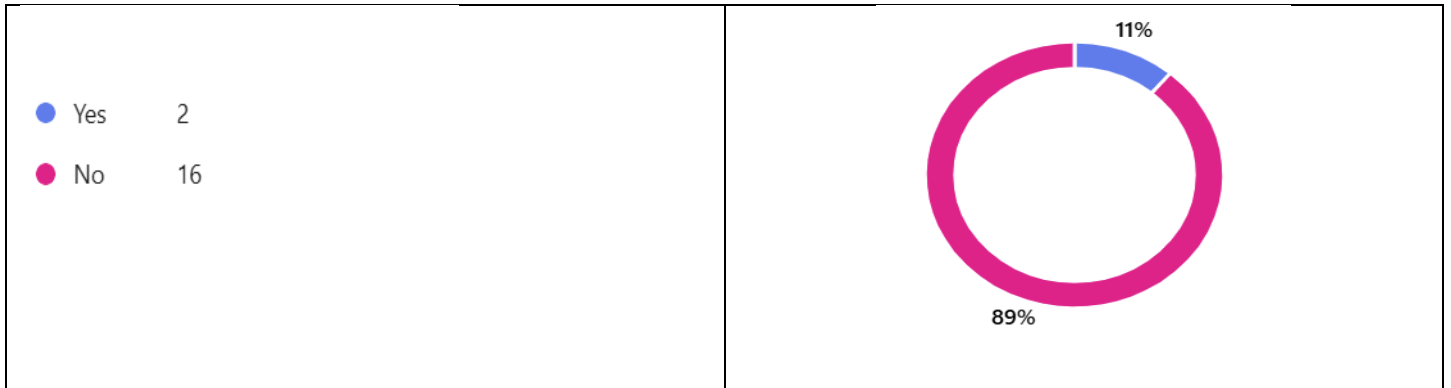
Question 9 - Do you want to answer a question about the people you care about?

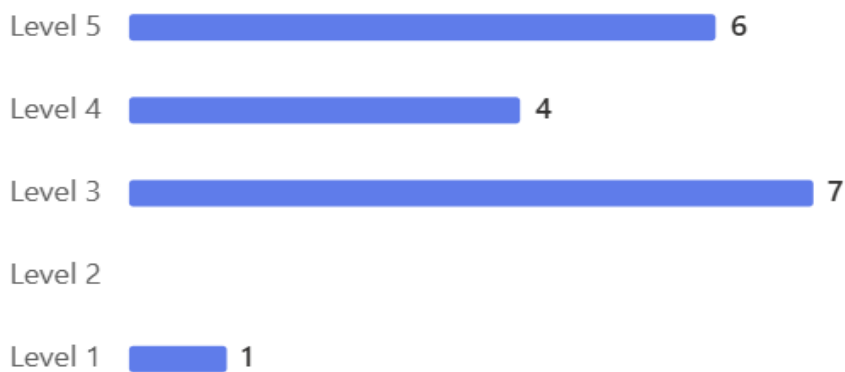
