IJB GOVERNANCE UPDATE

1. PURPOSE OF REPORT

1.1 IJB members have received previous briefing on improvements being made in relation to governance, focusing on the governance relationship between the IJB and the council and delivering on actions within the Ministerial Strategic Group Action Plan. This report provides a short update on progress to date and asks the IJB to note the documents attached to the report.

2. RECOMMENDATION

- i. Notes the update on the progress made in relation to IJB governance; and
- ii. Agree the refreshed minutes of IJB's two formal subgroups.

3. BACKGROUND INFORMATION

- 3.1 Members will be aware that officers are currently working to deliver the Ministerial Strategic Group Action Plan with includes actions on improving governance and accountability arrangements within the IJB. These actions were nationally determined following the Review of Progress Under Integration report published by Scottish Government and COSLA in 2019. Progress against these actions is reported regularly to the Performance and Audit Committee and recent activity has focused on clarification of the roles and responsibilities between the IJB and the Council.
- 3.2 A separate report is being taken to the council on 4th March, following the report on 10th November which was agreed to be carried forward to a future meeting. Since the November special council, HSCP and council officers have provided further briefing to all elected members offering clarification on the roles and responsibilities of the IJB and council in relation to integrated health and social care services.
- 3.3 Within this activity, officers have also committed to undertaking further work to make improvements and relevant updates to the IJB's governance, including:
 - Resolution of minor outstanding issues (e.g. role and frequency of Three Way Meeting) at officer level;
 - Development of complementary strategic documents for example, a refreshed Community Engagement Strategy; and,
 - Delivery of continuing training sessions to IJB members, Councillors, NHS Board members, and management to improve shared understanding of legislation and local processes.



4. REPORT

- 4.1 The purpose of this report, in addition to receiving an update on the activity outlined above, is for the IJB to formally agree the Terms of Reference of the two sub-committees: the Strategic Planning Advisory Group (SPAG) at Appendix 1; and the Performance Audit Committee at Appendix 2.
- 4.2 These SPAG Terms of Reference has recently been revised and endorsed by the meeting – following a refresh of the group's remit and membership. The Performance and Audit Committee Terms of Reference have not been substantively changed but this report provided the opportunity to formally agree both Terms of Reference which had not been reviewed for some time.

5. STRATEGIC CONTEXT

5.1 Governance is a crucial element of our effectiveness as a partnership our work to improve governance feeds into our current strategic priorities (in particular "We will manage resources effectively, making best use of our integrated capacity.") and aligns to Priority 5 of our draft Strategic Plan "We are an ambitious and effective Partnership". The work also reflects our contribution to the national MSG action plan action to improve IJB governance.
