LOCALITY PLANNING UPDATE

1. PURPOSE OF REPORT

1.1. The purpose of this report is to provide the SPAG with an update on recent meetings of the Locality Planning Partnerships (LPPs) and seek final agreement to a proposed way of incorporating views and experiences from the LPPs into the SPAG, per its remit.

2. **RECOMMENDATION**

- 2.1. The Strategic Planning Advisory Group are invited to:
 - i. Note the update from the Locality Planning Partnerships (LPPs);
 - ii. Note that the LPPs will receive a 'relaunch' in 2021;
 - iii. Note the LPP Chairs Terms of Reference at Appendix 1; and
 - iv. Agree the proposed approach to representing the LPPs at the SPAG.

3. BACKGROUND INFORMATION

3.1 At the previous SPAG meeting a proposed approach to ensure the perspective of members of Locality Planning Partnerships may form part of the agenda of the SPAG meeting. This approach was discussed at a Locality Planning Chairs/Vice Chairs meeting.

Essentially the approach supported Chairs/Vice Chairs meeting before SPAG meetings and agreeing salient points from 'locality planning' to be tabled at SPAG meeting, which this report sets out.

3.2 This report summarises issues related to Locality Planning in general in South Ayrshire and issues that emerged from the most recent Chairs/Vice Chairs meeting on 9th June 2021.

4. REPORT

Links from Locality Planning Partnerships to SPAG

- 4.1. The agreed way forward to ensure Locality Planning Partnership inputs into SPAG was that:
 - The Chairs and Vice Chairs of LPPs meet before the SPAG to discuss emerging issues and common themes that may then be formally tabled at SPAG
 - The Vice Chair of the SPAG would attend these meetings to ensure a good articulation between groups
 - A formal paper would be drawn up for the SPAG re Locality Planning
 - 2 or 3 representatives from the Chairs meeting would agree to attend the SPAG and speak to the report



 The Chairs/Vice Chairs meeting has draft Terms of Reference (attached) that set out the purpose of the meeting and its reporting links.

Proposals and planning for re-launch of Locality Planning

- 4.2. The previously agreed report to IJB re Locality Planning, which followed an iterative review process, set out a number of recommendations for future Locality Planning work. This included a process of renewal and reformation (building on some strong existing work) that was planned for Spring 2020. This was then paused during the Covid period and the associated restrictions (although the LPPs have been meeting monthly in virtual sessions since August 2020).
- 4.3. With the relaxation of some of the Covid restrictions it is proposed to have relaunch events in all 6 localities in September 2021.
- 4.4. These will bring together key stakeholders and interested parties in each locality (and including representation from associated villages and smaller communities) to discuss how locality planning might operate in each locality.
- 4.5. Planning has been initiated within each locality and outline dates and potential venues identified. Whilst wider information sharing activity may be desirable to complement the re-launch events, this may have to be modest because of Covid restrictions.
- 4.6. Engagement Officers are actively seeking links with local networks, agencies and other constituency representatives to ensure their engagement in the events. Similarly, there is work within the HSCP to ensure staff are likewise engaged and mobilised.
- 4.7. There will be a range of communication activity from June to September supporting this process.

The re-launch events might also allow for participants to attend remotely and technical advice is being sought to facilitate this.

A report on the outputs and agreed actions from these events will be reported back to a subsequent SPAG meeting.

4.1 Proposals re Decision Days/Local Grant making

- 4.8. During the Covid period, the normal Decision Days/Participatory Budgeting events were not appropriate. However a small grants process, led by the LPPs was initiated. This resulted in the support of 62 community groups with around £30k of resource given out. This was supporting projects in line with local priorities but also those supporting Covid related work.
- 4.9. With the relaxation of Covid restrictions, it is intended to hold PB/Decision Days in each Locality in the January- March 2022 period. (this will be subject to the level of activity allowed by early 2022).



- 4.10. South Ayrshire Council, has indicated some additional resource to support these events through national Covid related monies and there will be an additional £12k available to add to the already committed £30k from the HSCP.
- 4.11. The LPPs will lead on these events supported by their Community Engagement Officers.

4.2 Future LPP meetings

4.12. The Chairs/Vice Chairs group also wished to ensure future LPP meetings could involve a 'blended model' where people could attend in situ or remotely and this is being pursued. This would help in terms of Covid social distancing but also allow wider involvement from wider groups, for example, from villages and remote communities.
