Tragic Loss of Life - HSCP employee

3.1 The Management team and colleagues across the service were saddened to learn of a tragic accident on Friday 4th November, where Shona McKinlay, a valued member of the Mobile Attendant team lost her life. Another member of the team sustained physical injuries and is being supported during this difficult time. Our sincere condolences go out to family and friends who are grieving the loss of their loved one. Police Scotland are carrying out their investigation to the road traffic accident.

Adult Services restructure

- 3.2 Members will be aware that proposals for a restructure of Adult Services Management were agreed by the IJB in September. Subsequently, on 1 November the Council's Cabinet was asked to endorse those aspects of the new structure proposals affecting Council employees. The paper was agreed at Cabinet.
- 3.3 This restructure will now be progressed and where appropriate updates will be brought to the IJB for awareness.



Acute Services – 2 week intervention plan

- 3.4 In collaboration with colleagues in East and North, the HSCP is currently engaged in a 2 week focussed intervention to support discharge from the two acute hospital sites. The primary focus of this particular initiative is to enable the speedier discharge of people who do not require social care support. The aim is to support improved patient journeys in hospitals within Ayrshire and Arran NHS. In a multi-agency approach, staff groups from Acute, HSCP, Primary Care and other partners will work collaboratively in the hospital over a two week period starting on 7 November. The objectives include to identifying and improving ways of working which would reduce admissions, length of stay and delayed transfers of care
- 3.5 Outcomes will be achieved through better decision making, at expediting discharge more rapidly, preventing admission by improving the decision making process at the hospital front doors (CAU and ED) and identifying alternatives for people admitted with rapid turnaround (like use of Hospital at Home). Whilst there is a short term focus (2 weeks pre Winter) the process will also identify opportunities for medium and longer term learning and improvement.

<u>ADP</u>

- 3.6 South Ayrshire Alcohol and Drug Partnership held a very successful 'Learning Event' on Friday 4th November, hosted at the UWS. The event provided opportunity to attend in person for the first in many months to celebrate and learn how people can be and are supported and what is changing following the two year Learning Review undertaken by the ADP.
- 3.7 The ADP have worked tirelessly to implement improvements for the people of South Ayrshire and adopt a more flexible, accessible support network and are fully committed to the findings of the Learning Review. The ambition of how to do that is being progressed and updates will be brought to the IJB when appropriate.

Care Inspection update

- 3.8 Further to previous updates, the Joint Inspection of Adult Services is continuing. The Care Inspectorate are in the process of confirming the final files for file reading which will commence in the coming weeks. Themed Focus Groups will also be held which will identify how effectively partnership teams are working together, both strategically and operationally to achieve good health and wellbeing results for adults. Th focus groups are scheduled to take place between 2 – 16th December. The themes for focus groups are:
 - Front line staff
 - Team leaders/service leaders
 - Third sector and private providers
 - Planners and commissioners
 - Senior Managers
